

## **Terms and Conditions for Hamble Lifeboat Charity Walk**

**1. Introduction** These Terms and Conditions apply to all participants of the Hamble Lifeboat Charity Walk (hereinafter referred to as "Doin the 'Amble Walk"). By registering for the Walk, participants agree to comply with these Terms and Conditions.

### **2. Eligibility**

- All participants must register for the Walk via the official Just Giving page on Hamble Lifeboat website.
- Participants under the age of 18 must have permission from a parent or guardian to participate.

### **3. Health and Safety**

- Participants acknowledge that they undertake the Walk at their own risk and are responsible for their own health and safety.
- Participants should ensure they are physically fit and capable of completing the Walk. If in doubt, participants are advised to seek medical advice before commencing the Walk.
- Participants must adhere to local health and safety regulations and COVID-19 guidelines in place at the time of the Walk.

### **4. Route and Timing**

- Participants can complete the Walk at their own pace and in their own time within the designated timeframe set by Hamble Lifeboat.
- Participants are responsible for planning their own route in and around Hamble and surrounding areas, ensuring it is safe and legal.

### **5. Liability**

- Hamble Lifeboat shall not be held liable for any injury, loss, or damage suffered by participants during the Walk.
- By participating, participants agree to waive any claims against Hamble Lifeboat, its trustees and volunteers arising out of or in connection with their participation in the Walk.

### **6. Conduct**

- Participants are expected to conduct themselves in a manner that is respectful to the community, the environment, and other individuals.
- Any form of misconduct, including littering, vandalism, or disruptive behaviour, is strictly prohibited.

## **7. Fundraising**

- Participants are encouraged to raise funds for Hamble Lifeboat. All funds raised must be donated to Hamble Lifeboat in accordance with the guidelines provided upon registration.
- Participants must not collect funds for any other charity or cause during the Walk.

## **8. Photography and Media**

- By participating in the Walk, participants consent to being photographed and filmed by Hamble Lifeboat or its representatives. These images and videos may be used for promotional purposes.
- Participants who do not wish to be photographed or filmed must notify Hamble Lifeboat in writing prior to the Walk.

## **9. Data Protection**

- Hamble Lifeboat will process participants' personal data through Just Giving in accordance with applicable data protection laws and its Privacy Policy.
- Participants' personal information will only be used for the administration of the Walk and any other purpose to which they have consented.

## **10. Changes and Cancellation**

- Hamble Lifeboat reserves the right to make changes to these Terms and Conditions at any time. Participants will be notified of any significant changes.
- In the event of unforeseen circumstances, Hamble Lifeboat reserves the right to cancel the Walk. Participants will be informed as soon as practicable.

## **11. Governing Law**

- These Terms and Conditions shall be governed by and construed in accordance with the laws of England and Wales.
- Any disputes arising under or in connection with these Terms and Conditions shall be subject to the exclusive jurisdiction of the courts of England and Wales.

## **12. Acceptance of Terms**

- By registering for and participating in the Walk, participants confirm that they have read, understood, and agree to these Terms and Conditions.
